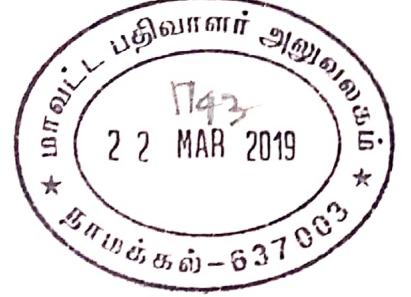

Date: 25th December 2018

Venue: Hotel Silver Line Retreat, Kolli Hills

Participants: 5 Board members and 9 guests from outside.

- 1. Changes in the Management team:** Mr. Jabez John, Mr. Balaji. N (Board member of Abhinavgram Society) being relieved from Abhinavgram society from 25th December 2019. The Board of management agreed to join Mr. Sadeeshkumar, B.com, MA (Gandhiyan Studies) as an Executive Member of the Society from 25th December 2018 upto September 2019-20 a tenure basis. Totally 7 members available in the board.
- 2. Manage Administration cost from CSR and funding organization:** To approach for funds from CSRs and funding organization to manage Administration cost to strengthen and sustain Abhinavgram for upcoming 1 to 2 years.
- 3. Funding for Honey harvesting project:** It was suggested to focus on funding from private and government organization for the honey harvesting project. It was also recommended to involve only women in this project.
- 4. Improvise Banana fibre project:** It was suggested to strengthen the project financially through production of additional products in the form of kurtas ,saree, chudidhar made from banana fiber materials to increase the viability of marketing.
- 5. Strengthen farmer cluster, practice methods & direct marketing:**
 - To work towards creating a data base for farmers with individual farmer details in the 18 farmers clusters that includes data on family back ground and assets of the farmers. It was also suggested to improve the rapport among farmers.
 - Spices and coffee clusters to be strengthened and to look for options on how to engage stakeholders and individual farmers.
 - Organic method to be implemented and reinforced in routine practice.
